### CONSTRUCTION NOTICE UPDATE - PHASE 3

As a follow-up to the construction updates for the City of Omaha sanitary sewer force main project from the East Omaha Lift Station to 11th Street, please be advised of the following schedule update for construction pertaining to Phases 1 and 2 under construction and **Phase 3 beginning the week of March 25<sup>th</sup>**. Here's what to expect during these phases of construction.

#### Phase 1: 11<sup>th</sup> Street – RR Tracks to Avenue H

- A majority of Phase 1 has been completed with the exception of the crossing for the 11<sup>th</sup> Street connection within the railroad right-of-way. This connection has been delayed until further notice.

#### Phase 2: Avenue H – 11<sup>th</sup> to 5<sup>th</sup> Streets

- Phase 2 continues to progress and is anticipated to be completed in early April, pending weather conditions.

#### Phase 3: Avenue H – 5<sup>th</sup> to 9<sup>th</sup> Streets

- **Phase 3 will be starting the week of March 25<sup>th</sup>** with work taking place west of 9<sup>th</sup> Street followed by operations from 5<sup>th</sup> to 9<sup>th</sup> Streets and is anticipated to be completed in late May.

#### Traffic Control/Restrictions

- Access to Avenue H between 11th and 5th Streets will continue to be maintained along an alternate route utilizing Abbott Drive, Avenue H, 9th Street, and Avenue J.
- Avenue H from 11<sup>th</sup> to 5<sup>th</sup> Streets will continue to be closed to through traffic with one lane open at all times to allow local traffic access only to adjacent properties located within Phase 2.
- Access to 5th and 9th Streets along Avenue H will be maintained at all times during Phase 3 with any restrictions to access being coordinated by the Contractor with the adjacent property owners.
